

BMJ Case Reports Author Fellow Terms and Conditions

These terms and conditions set out the conditions relating to becoming a Fellow for BMJ Case Reports. This applies to all **Corresponding Authors** who submit a case report to the BMJ Case Reports website. The first 100 Corresponding Authors will not be charged fellowship fees before 31 December 2009. Please note for multi-authored works, non-Corresponding Authors will need to apply separately to the BMJ Group to become a Fellow of BMJ Case Reports.

1. What is included as a Fellow?

- 1.1. Fellows can submit an unlimited number of case reports to be considered for publication during their fellowship term
- 1.2. Fellows have a personal, non-exclusive, non-transferable right to access online the full text of all published articles on BMJ Case Reports, and any additional rights contained within our Author Assignment (see below)
- 1.3. Access will occur when you are able to access the BMJ Case Reports and delivery shall be deemed to take place once a contract comes into effect (thus subject to acceptance of your offer).

2. Placing an order and our acceptance

- 2.1 When submitting your case reports you will be asked to accept these terms and conditions. The first 100 Corresponding Authors to submit an article will not be charged to submit articles or access the BMJ Case Reports site for the period up until 31 December 2009. For all other Corresponding Authors submitting before 31 December 2009 we will charge you the price indicated on the BMJ Case Reports website when you submit your case report. For case reports submitted from 1 January 2009, fellowship will be for 12 months from when our contract comes into effect and based on the standard pricing indicated on our website.
- 2.2 If you wish to cancel any Fellowship, as this is a periodical, you will have no contractual right to do so and acceptance of that cancellation request shall be at our discretion and if accepted, may be subject to a cancellation charge. This shall not effect your statutory rights.
- 2.3 When you do submit your case report you are making an offer to purchase a BMJ Case Reports Fellowship, which we may accept or decline. A contract for BMJ Case Reports Fellowship will come into effect within 5 working days from the date of submission unless we have contacted you to advise

otherwise. We will however prior to that time allow you to have temporary access online to the published case reports but this is a gesture of goodwill, and does not represent acceptance of your offer. We have included this term to protect us in the case that a mistake has been made in pricing on the website, if we have inadvertently under-priced goods, or we are no longer able to supply a particular product for some reason.

2.4 Access is subject to availability, and BMJ Case Reports continuing to be owned by us. In the event that we are unable to supply access for the agreed term, we will inform you as soon as possible and provide you with a pro rata refund in the event that you have paid for a period for which we cannot comply. We will not however be liable for any other direct or indirect losses nor any losses (as set out in Clause 5), caused as a result of not being able to supply you with BMJ Case Reports for the periods subscribed to. This does not affect your statutory rights

3. Your Account Details

If your Fellowship is accepted, you will be responsible for maintaining confidentiality of your online account and password, restricting access to your computer and/or prevent unauthorised access to your account. You agree to take responsibility for all activities that occur under your account or password. If you believe that your account or password is being or is about to be used by anyone else you should inform us immediately via bmjcases@bmjgroup.com

4. Payments

- 4.1. The price that you pay for your Fellowship should be the standard pricing as indicated on the website, which will depend on your billing/invoice address. These prices are valid for purchases during the calendar year which the purchase relates to. You will be charged in the currency as indicated.
- 4.2. Whilst we try to ensure that all of our prices on our website are accurate, errors may occur. If we discover any error in the prices of the Fellowship you have ordered, we will inform you as soon as possible and give you the option of recommencing your order at the correct price or cancelling it. If we are unable to contact you and the price is more expensive we will treat the order as cancelled. If you cancel for this reason and we have already processed your payment, you will receive a full refund.
- 4.3. For those that submit requests for Fellowships before the end of 2008, payment will be due within 30 days of the date of invoice unless otherwise indicated or agreed. Payment may be made by the methods indicated on the invoice.
- 4.4. For offers for Fellowships once you are able to purchase online, payment will be due as set out on our website.

5. Losses

- 5.1. We try to ensure that website availability is uninterrupted and that transmissions will be error-free. However, we cannot, guarantee that your access will not be suspended or restricted for reasonable periods from time to time, including to allow for repairs, maintenance or the introduction of new facilities or services. We of course try to limit the frequency and duration of any

suspension or restriction

- 5.2. We will not be liable for any direct or indirect loss or consequential losses (including loss of profit, revenue, contracts, anticipated savings, data, goodwill or wasted expenditure), other than as stated in Clause 5.3 or when your subscriptions cannot be fulfilled, and in which case, our liability to you will be as set out in clause 2.4.
- 5.3. We do not however exclude or limit our liability for death or personal injury caused from our negligence or fraudulent misrepresentation, nor does this affect your statutory rights.
