

Author Assignment of Intellectual Property Rights to BMJ Publishing Group Limited ("BMJ")

To be agreed to by the corresponding author or guarantor on behalf of all authors, ("Corresponding Author"). All authors are collectively referred to as the "Contributors".

In consideration of BMJ considering to publish the case report (which includes without limitation any diagrams, photographs and/or illustrative material, video, film or any other material howsoever submitted by the Corresponding Author or other contributors at any time as and related to the Case Report which are owned by the Corresponding Author and other Contributors ("the Contribution")) in its online product currently called BMJ Case Reports ("BMJ Case Reports"), certain rights are required to be assigned or granted by each different category of Contributor(s) which are as follows:

1. Other than as stated in Clauses 2 and 3 below, a copyright assignment, as set out under the heading "The Copyright Assignment" below.
2. For employees of the **UK Crown acting in the course of their employment**, or **National Institute of Health employees, contractors or trainees**, a non exclusive licence, as set out under the heading "the Licence" below. All provisions of this document apply. The non exclusivity relates to the original submitted manuscript, films, images or diagrams only.
3. For employees of the **US Federal Government acting in the course of their employment** no copyright exists and the Contribution is in the public domain so no licence is required to be granted. The Contributor Warranties below apply (excluding 1.iii).

NB where a Contribution is a multi-authored work, each Contributor's element of the Contribution will be dealt with in accordance with Clauses 1, 2 or 3 above, as applicable.

The Copyright Assignment

The assignment granted by the Contributors in accordance with Clause 1 above is as follows (subject to the Reversion of Rights set out below):

i) the entire copyright and all rights in nature of copyright and all other intellectual property rights, whether vested, contingent or in future throughout the world in the Contribution (including all updates and other material written for BMJ), and for the avoidance of doubt this includes all editions and subsidiary rights for the full term of copyright and all renewals and extensions thereof and to licence for publication, the Contribution in whole and

in part all editions, forms and media in the English language and in any translations, and without limitation; and

ii) all rights of infringement action or cause of action and all other rights of whatever nature in the Contribution, whether known or in the future created to which the Contributor is now or may at any time after the date of this Agreement be entitled by virtue of or pursuant to any of the laws in force in any part of the world.

In circumstances where the Corresponding Author or any Contributor is an employee acting in the course of their employment in producing the Contribution, the Corresponding Author warrants on behalf of itself and all Contributors that it has obtained all necessary written releases required to assign the rights herein from their employer(s) with respect to the Contribution.

The Licence

The Licence granted in accordance with Clause 2 above is: A worldwide licence to BMJ and its licensees in perpetuity (subject to the Reversion of Rights set out below), in all forms, formats and media (whether known now or created in the future), to i) publish, reproduce, distribute, display and store the Contribution, ii) translate the Contribution into other languages, create adaptations, reprints, include within collections and create summaries, extracts and/or, abstracts of the Contribution, iii) create any other derivative work(s) based on the Contribution, iv) to exploit all subsidiary rights in the Contribution, v) the inclusion of electronic links from the Contribution to third party material wherever it may be located; and, vi) licence any third party to do any or all of the above.

If the Corresponding Author's or any Contributors' employers own the copyright to the Contribution, you must obtain relevant employers' written consent to grant the assignment or licence (as applicable) and their agreement to any applicable obligations herein. The Contributor(s) hereby agree that, in the event that BMJ sells the whole or part of its journal business to any third party, the benefit and the burden of the Assignment or Licence contained herein shall be assigned to that third party.

In all cases whether in the Assignment or the Licence, the Corresponding Author irrevocably and unconditionally waives all moral rights in respect of the Contribution to which he/she may now or at any time in the future be entitled under any relevant legislation and has secured

such a waiver from all other Contributors. The Corresponding Author declares this/these waiver(s) shall operate in favour of BMJ.

Reversion of Rights

If the Contribution is not published in BMJ Case Reports or any other BMJ product, within 12 months of final acceptance by BMJ, (or as otherwise agreed), the assignment herein shall automatically terminate and all rights shall revert to the copyright owner. BMJ may keep a copy of the Contribution as a record (including via any contractor).

Changes and Updating

The Contributor(s) acknowledge and accept that BMJ may make additional changes to the Contribution as considered necessary in accordance with standard editorial processes whether before or after publication. The Corresponding Author will usually see proofs of their articles and every effort will be made to consult with the Corresponding Author if substantial alterations are made. BMJ may also retract or publish a correction or other notice when it considers this appropriate for legal or editorial reasons and this shall be at its absolute discretion which shall be exercised reasonably.

BMJ may approach the Corresponding Author to assist with updating the Contribution but is not obliged to do so and reserves its full editorial control over Contribution, including removal in whole or part of the Contribution and allowing third parties to amend or alter the Contribution. Any such agreed updating services from the Corresponding Author however shall be performed according to such specifications & timing which shall be mutually acceptable to both parties and evidenced in writing and shall otherwise be governed by the terms of this Agreement unless expressly indicated otherwise.

Rights Granted to Contributors of the Contribution

In return for the assignment of intellectual property rights, the Corresponding Author shall have the following rights for **non-Commercial Use (unless otherwise stated)*** of the Contribution and the right to allow any other named Contributor(s) of the Contribution to make the same uses (subject to the Corresponding Author supplying them with a copy of the Contribution) :

1. The right to reproduce a reasonable number (no more than 100) of print copies of the final Contribution, by copying or downloading from the BMJ's website, for personal use and to send copies to colleagues in print or electronic form provided no fee is charged, such colleagues are advised that their

use must be for non Commercial Use and this is not done on a systematic basis (which includes via mass e-mailings).

2. The right to include the Contribution in a compilation for classroom use (course packs) to be distributed free of charge (other than for direct photocopying costs) to students at the Contributor's institution or to be stored in digital format in data rooms for access by students as part of their course work and for in house training programmes of the Contributor(s)'s employer or at seminars or conferences subject to a limit of 100 copies.
3. The right to publish with the necessary acknowledgement all or part of the material from the published Contribution in a book, essay, position paper, or other non peer reviewed publication authored or edited by the Contributor(s) (which may be a Commercial Use). This does not apply to multiple Contributions, for which permission from BMJ must be sought.
4. The right to use selected figures and tables (of which the Contributor or his employer owns or has licensed) and selected text (up to 250 words) from the Contribution for incorporation within another work published in print or digital format by a third party, so long as credit is given to BMJ and use of the parts of the Contribution (which may be a Commercial Use).
5. The right to:
 - a. post the accepted manuscript (but not the final published version of the Contribution), and the abstract of the final published Contribution on the Contributor(s)'s own and/or his/her institution's website, 6 months after date of being published online;
 - b. only in order to comply with a recognised list of funding bodies' policies (<http://www.sherpa.ac.uk/juliet/>) to place the accepted manuscript version but not the final published version on PMC (including for deposit by PMC on its international mirror sites) after an embargo period of 12 months from date of being published online unless otherwise stated by the funding body.

The following statement must accompany the article posted on the Contributor(s)'s and/or his/her institution's website:

- vii) that they have declared or will accurately declare all competing interests to BMJ.

Anti Bribery

Alterations to this Agreement are only valid if they are recorded in writing and signed by both parties. In the event that any provision of this Agreement is held to be invalid, the remainder of the provisions shall continue in full force and effect.

Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England without regard to the principles of conflicts of law. The parties hereto submit to the exclusive jurisdiction of the English courts.
